Release Notes for 3.5.6.2

GemStone/S 64 Bit $^{\text{TM}}$ 3.5.6.2 is a limited-distribution special release version of the GemStone/S 64 Bit object server.

These Release Notes include changes between the previous version of GemStone/S 64 Bit, v3.5.6.1, and v3.5.6.2.

Supported Platforms

GemStone/S 64 Bit version 3.5.6.2 is supported on Linux only, and with clients running on Windows and Linux.

Upgrade

GemStone/S 64 Bit v3.5.6.2 contains no image-level changes from v3.5.6.1. In v3.5.6.1, the only changes was a added private method to support internal build and archiving processes. While running **upgradeImage** is generally recommended, it is not required when upgrading from 3.5.6 or 3.5.6.1. For these upgrades, you may restart GemStone with the new executables without running **upgradeImage**.

VSD Version

The GemStone/S 64 Bit v3.5.6.2 distribution includes VSD version 5.5.3. The previous version of GemStone/S 64 Bit, v3.5.6.1, included a prerelease version os VSD v5.5.2. VSD v5.5.3 includes improved search and updated help.

Print GCI trace records on protocol error

To aid in analysis of GCI protocol errors, recent GCI call history is now automatically printed to the gem log when a GCI protocol error occurs. GCI call trace records are maintained in a wraparound buffer, and the most recent 100 records will be printed to the log.
